THE FOLLOWING ITEMS ARE REQUIRED TO BE PRESENTED TO THE DCCA STAFF FOR APPROVAL IN ORDER TO REGISTER OR RENEW:

- VALID (CURRENT) VEHICLE REGISTRATION IN THE COMPANY NAME
- VALID (CURRENT) VEHICLE INSURANCE
- VALID (CURRENT) DRIVER'S LICENSES FOR ALL COMPANY DRIVERS

REQUIRED ITEMS MUST BE SUBMITTED EACH YEAR WITH PAYMENT

A Fleet Annual registration allows a minimum of four (4) and maximum of ten (10) vehicles to obtain a Decal/Barcode for an initial fee of \$500.00. There will be a \$50.00 charge for each additional vehicle over the ten (10) vehicle limit. Barcodes are assigned to and for an individual's exclusive use and are valid only for the vehicle to which it is assigned. Guests accompanying workers will not be allowed. The below vehicle information is required before any Decal/Barcode will be issued. If a vehicle is traded, or windshield replaced the decal/barcode must be removed and returned to DCCA before a new Decal/Barcode can be issued.
