

# **Boat Decal Policy**

Effective: July 1, 2001 Revised: November 19, 2011

## I. <u>PROPERTY OWNERS</u>

- Property Owners will pay \$15 per each boat registered, maximum of to two boats. Additional boats may be registered for a fee of \$35 per boat and must be approved by the General Manager.
- 2) To register a boat, property owners must present a current state registration card evidencing ownership of that boat, to the Security Office. Security will then issue a numbered decal to the property owner to be affixed to the boat and trailer. The registration application will include a signed certification that the property owner agrees to abide by the DeBordieu boating rules and regulations.
- 3) A property owner may register a boat owned by a member of the property owner's immediate family; specifically limited to mothers, fathers, daughters, sons, sons-in-law, and daughters-in-law. The property owner must request such registration in writing and must specify the relationship of the boat owner to the property owner. They must also certify that the boat owner agrees to abide by the DeBordieu Boating Rules and Regulations.
- 4) Non-property owners cannot register a boat under any circumstances.

#### II. GUESTS OF PROPERTY OWNERS

1) A property owner may request a "Guest Pass" for boats owned by their guests. The guest will be responsible for paying a usage fee as follows:

- 2) A boat authorization tag will be affixed to the guest pass that is to be displayed at all times on the driver's side of the vehicle dashboard.
- 3) If usage of the facilities by guests begins to interfere with the ability of community members to use the facilities, a limit on the number of guest passes issued may be instituted, particularly on highly congested weekends.

### III. RENTERS AND GUIDES

- 1) Renters will be subject to the same fees as a guest. If a renter brings a boat in for a week he/she must purchase a one-week pass. If a renter is staying longer than one week, the renter must purchase additional passes from Security for the duration of the rental. The maximum period of duration for a rental guest pass will coincide with the rental contract.
- 2) Fishing guides may be approved for 24 hour passes, however the property owner must notify Security in advance that a fishing guide is being contracted. Approval is contingent upon verification of "employment" by a property owner or renter.

### IV. TERMS AND CONDITIONS

- 1) All boats must be trailered and removed from the boat dock. No boats may be left at the dock or stored overnight in the boat parking area. No trailers may be left in boat/trailer parking area.
- 2) Money collected from boat decals will be invested in maintaining the boat ramp, parking lot and the boat storage area.
